| <b>FACTS</b> | <b>What do we do with your personal information?</b>   |
| <b>Why?</b>  | Financial companies choose who they share your person information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.   |
| <b>What?</b> | <p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>● Social security number</li> <li>● Income</li> <li>● Payment history</li> <li>● Credit history</li> <li>● Employment information</li> </ul> <p>When you are no longer our guest, we continue to share your information as described in this notice.</p> |
| <b>How?</b>  | All financial companies need to share guests' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their guests' personal information; the reasons we choose to share; and whether you can limit this sharing.   |

| How is my personal information collected? | We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>● Apply for a loan</li> <li>● Provide your income and/or employment information</li> <li>● Apply for financing or a lease</li> <li>● Pay us by check</li> <li>● Show your driver’s license and/or other government-issued ID</li> </ul> We also collect personal information from others, such as credit bureaus, affiliates, or other companies. |
| Why can’t I limit all sharing?            | Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>● Sharing for affiliates’ everyday business purposes – information about your creditworthiness</li> <li>● Affiliates from using your information to market to you</li> <li>● Sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.  |

| Affiliates         | Companies related by common ownership or control.
