

## **Privacy Policy –Harley-Davidson Riyadh**

We, HARLEY-DAVIDSON® RIYADH, Exit-5 North Ring Highway Al Masaf Area, P.O. Box 86602, Saudi Arabia 11632, collect and use certain types of information about the visitors of our website and store, our customers, including their legal representatives (if applicable), prospective customers, participants in our contests, prize draws, promotions, surveys or events and persons who request to receive information about our products and services. This policy sets out what information we collect and how we use it.

By using our website or providing us with information about you, you consent to the collection, processing, sharing and transfer of that information, including outside of your country of residence, consistent with this Privacy Policy.

### **What information about you do we collect and use?**

We may collect your name and contact details, IP address, job title, credit card number and financial data, driving license and identity cards, gender, birthday, personal interests and other information that you voluntarily provide, sales orders and history, information related to your motor cycle, product warranties, guarantees and repairs. We may also collect information about your use of this website, demographic and geographic information, your product and service interests and preferences as well as marketing preferences.

### **Where do we get the information about you from?**

You may provide information about you directly to us or we may collect it when you contact us directly, normally via our website [**or our customer service team**], when you place an order, make an enquiry, contact us with a question or concern, participate in a contest, promotion, surveyor event or visit our store. We may also receive information from other authorized Harley Davidson dealers, Harley Davidson Inc. and its subsidiary and affiliate entities, selected business partners and occasionally from other third parties and may combine this information with the information we already have about you.

### **For which purposes do we collect and use information about you?**

We may collect and use information about you for one or more of the following purposes:

- to provide motorcycles, products and services you have ordered or asked for, to process and fulfill your orders and to exercise or comply with our contractual or statutory rights and obligations, including with respect to guarantees and warranties (if applicable), billing and shipping;
- to provide information or quotes you requested and to respond to your queries;
- to review and qualify you for financing, if you are interested;
- to improve the quality of our website as well as our and Harley Davidson products and services;
- to learn more about your product and service preferences and to personalize and enhance your experience and our as well as Harley Davidson products and services based on your personal profile;
- to administer and conduct contests, prize draws, promotions and events;
- for advertising and to provide and update you with news and information about our as well as Harley Davidson products, services, membership programs, contests, prize draws and

promotions, unless you told us that you do not want to receive such marketing messages, and occasionally for surveys, analysis and market research;

### **With whom do we share information about you?**

We may share information about you for any of the afore-mentioned purposes with:

- Harley Davidson Inc. and its subsidiary and affiliate entities and their business partners who provide Harley Davidson branded products or services;
- other authorized Harley Davidson dealers;
- service providers who perform services on our behalf, such as most IT providers and mail services;
- Our business partners, such as marketing agencies, or other parties if you sign up for their services.

We may also share your information with third parties, including law enforcement agencies and courts, for legal or regulatory purposes, if we sell our business or for the purpose of preventing fraud.

### **Do we transfer information internationally?**

Some of the third parties with whom we share information about you are located outside the European Union in countries that do not provide the same level of protection as in our country. However, we have taken safeguards to protect the information so transferred.
